A RESOLUTION OF THE TOWN OF HOCHATOWN RECOGNIZING CERTAIN ROADS WITHIN THE MUNICIPAL BOUNDARIES OF THE TOWN OF HOCHATOWN AS ROADS MAINTAINED BY THE MCCURTAIN COUNTY BOARD OF COUNTY COMMISSIONERS, AND AUTHORIZING THE MAINTENANCE OF SUCH ROADS BY THE TOWN OF HOCHATOWN
